Veikkaus Oy will operate, monitor and update their terminals thanks to FDJ Gaming Solutions' terminal management suite (TMS).

Timothée Carrus, CEO of Groupe Carrus said: 'This contract is a new success for our gaming terminals (Elite range) and a major achievement for the strategic partnership between Carrus Gaming and FDJ Gaming Solutions. It is a new milestone in our joint success story as we cooperate for more than 20 years delivering over 330,000 lottery terminals worldwide.'

Veikkaus Oy developers build Electron-based sales application, concentrate on business logic while DDP takes care of the terminal functions, image analysis and embeds native connection to the TMS. It is also the first time we deliver TMS as a service from the cloud.'
